MINUTES

The regular meeting of the Upshur County Emergency Services District No. 2 Commissioners was held on January 16, 2024, at the Diana Fire Station, 10496 State Hwy. 154E, Diana, Texas 75640.

- 1) Open meeting. The meeting was opened at 7:00 p.m. by Gaston DeBerry, III.
- 2) <u>Call to order</u>. Gaston DeBerry, III called the meeting to order. Prayer was led by Gaston DeBerry, III.
- 3) <u>Determine quorum present</u>. Gaston DeBerry, III determined a quorum with Tommie Whitaker, Rita Criswell, and Kenny Hankins being present. Gregg Price was absent.
- 4) Public comment. None
- 5) Election of officers.

President: Motion by Kenny Hankins with a second by Tommie Whitaker to nominate Gaston DeBerry, III as President. Motion carried 3-0 with Gaston DeBerry, III abstaining. Vice-President: Motion by Kenny Hankins with a second by Rita Criswell to nominate Tommie Whitaker as Vice-President. Motion carried 3-0 with Tommie Whitaker abstaining. Treasurer: Motion by Tommie Whitaker with a second by Rita Criswell to nominate Gregg Price as Treasurer. Motion carried 4-0. Unanimous vote in favor. Secretary: Motion by Tommie Whitaker with a second by Kenny Jankins to nominate Rita Criswell as Secretary. Motion carried 3-0 with Rita Criswell abstaining.

- 6) Read and approve minutes from the meeting held December 19, 2023. Motion was made by Tommie Whitaker with a second by Kenny Hankins to approve the minutes of the meeting held December 19, 2023 as written. Motion carried 4-0. Unanimous vote in favor.

Rita Criswell announced that she would be unable to attend. Motion carried 4-0. Unanimous vote in favor.
- 10) <u>Hear from Ray Hubbard with VFIS and take action if necessary</u>. Ray Hubbard was unable to attend due to the weather.
- 11) <u>Discuss and take action regarding dispatching concerns</u>. Kenny Hankins and other members present commented that they would like to have dispatchers send a second page, have the console manned 24 hours, and also notify who has been dispatched to a call. Gaston DeBerry, III announced that he and Tommie Whitaker had been to visit with Chief Jerry Taylor of the Gilmer Fire Department regarding these issues and he indicated that the contract would need to be amended.
